

## **Emirates NBD Mega Loans Campaign 2024 Terms & Conditions**

These terms and conditions ("Promotion Terms and Conditions") govern the Emirates NBD Mega Loans Campaign 2024 ("Promotion")

by Emirates NBD Bank (P.J.S.C) ("Bank"). This Promotion is subject to the Bank's General Terms and Conditions for Consumer Banking Products (for individual customers)/ General Terms and Conditions for Business Banking Products (for business banking customers), as applicable available on the Bank's website

### 1. Promotion
